

ORDINANCE NO. 2

FILE 2-2022-2023

AN ORDINANCE OF THE CITY OF ROPESVILLE, TEXAS, LEVYING AD VALOREM TAXES FOR THE USE AND SUPPORT OF THE ROPESVILLE MUNICIPAL GOVERNMENT OF THE CITY OF ROPESVILLE, TEXAS FOR THE 2022-2023 FISCAL YEAR; PROVIDING FOR APPORTIONING EACH LEVY FOR SPECIFIC PURPOSES; AND PROVIDING WHEN TAXES SHALL BECOME DUE AND WHEN SAME SHALL BECOME DELINQUENT IF NOT PAID.

BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF ROPESVILLE,

SECTION 1: That there is hereby levied and there shall be collected for the use and support of the municipal government of the City of Ropesville, and to provide the interest and sinking fund for the 2022-2023 year, upon all property. Real, personal and mixed, within the corporation limits of said city subject to Taxation.

A Tax of \$ 0.532808 on each/\$100.00 valuation of property, said tax being so levied and apportioned to the specific purpose here set forth:

- a) For the Maintenance and support of the general government (General Fund) \$0.532808 for each/\$100.00 dollars valuation of property and:
- b). For the interest and sinking fund \$00.00/each \$100.00 valuation of property.

Section 2: That the Taxes levied under this ordinance shall be due October 1, 2022, and paid on or before January 31, 2023. And shall become immediately delinquent after the 31st day of January 2023 or on the first (1st) day of February 2023.

Section 3: That all taxes shall become a lien upon the property against which assessed, and the city secretary or their established collection agent is hereby authorized and empowered to enforce the collection of such taxes according to the constitution and of the State of Texas and ORDINANCE of the City of Ropesville shall, by virtue of Tax Roll FIX and establish a lien by levying upon such property whether real or personal for the payment of said taxes, penalty, and interest. The penalty and interest collected for, such delinquent taxes shall be appointed to the General fund of the City of Ropesville. All delinquents shall be at the rate prescribed by the State of Texas Law.

Section 4: That this Ordinance shall be in the best interest of the Citizens of the City of Ropesville and shall take effect and be enforced from and after its passage.

Passed this 18 Day of August at a regular council meeting of the city alderman for the City of Ropesville.
