

**RESOLUTION NO.062022-1**

**A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD MAY 7, 2022, FOR THE PURPOSE OF ELECTING A MAYOR AND TWO (2) COUNCILMEMBERS TO THE CITY COUNCIL OF THE CITY OF ROPESVILLE, AND CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE REGULAR ELECTION HELD ON MAY 7, 2022, FOR THE PURPOSE OF ELECTING A MAYOR AND COUNCILMEMBER FOR AN UNEXPIRED TERM ENDING MAY 2024**

**WHEREAS**, a general election was held in the City of Ropesville, Texas, on May 7, 2022, for the purpose of electing a Mayor and (2) Councilmembers; and

**WHEREAS**, a special election was held in the City of Ropesville, Texas on May 7, 2022, for the purpose of electing a Councilmember for a unexpired term ending May 2022, and

**WHEREAS**, said elections were duly and legally held in conformity with the election laws of the State of Texas, and the results of said elections have been verified and returned by the proper judges and clerks; and

**WHEREAS**, it appears that a total of 59 votes were cast in such election; now, therefore,  
**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROPESVILLE, TEXAS:**


